## **Committee Reports**

**Finance Report** - Jennifer Braun, HS/EHS Director, in lieu of Ashley Keplinger, Treasurer, shared the Finance Report.

<u>Head Start Financial Report</u> – July, 2023 with grant end date of January 31, 2024. The total remaining in the grant was \$703,709.15 with current month expenditures at \$30,581.81. Administrative costs were at 10%. In-kind was at \$28,240.82

Early Head Start Financial Report – July, 2023 with grant end date of January 31, 2024 - The total remaining in the grant was \$577,637.13 with current month expenditures at \$55,111.97. Administrative costs were at 11%. In-kind was at \$36,903.06.

<u>USDA</u> – July, 2023 funds received for the month were \$2,499.69. August 2023 funds received for the month were \$2,9992.73.
